This action amends 3VAC10-40 Regulated Operations to advance public health and safety, provide additional clarity and transparency, codify existing practices, adopt accepted industry best practices, and comport with Chapter 732 of the 2024 Acts of Assembly.

This action adds and amends definitions to provide clarity for terminology such as cartoon, immediate container, and packaging. This action also reinforces and implements the statutory requirements of § 4.1-1601 by prohibiting permittees from endorsing practitioners, codifies the current practice of permittees using electronic tracking, and establishing public health and safety standards for the transportation and delivery of medical cannabis including vehicle inspections, GPS tracking, and incident and accident protocols.

On October 9, 2024, the CCA Board of Directors voted to approve amendments to the regulations of the medical cannabis program.

Mandate and Impetus

The CCA Board of Directors determined it was necessary to amend the medical cannabis program regulations to clarify ambiguities that have resulted in numerous inquiries to CCA staff, properly address current practices, incorporate industry best practices for safety and accountability, and comport with Chapter 732 of the 2024 Acts of Assembly. Per § 4.1-1602 Q, "[w]ith the exception of § 2.2-4031, neither the provisions of the Administrative Process Act (§ 2.2-4000 et seq.) nor public participation guidelines adopted pursuant thereto shall apply to the adoption of any regulation pursuant to this section."
