The regulation amendments update state regulations that incorporate by reference certain federal regulations to reflect the Code of Federal Regulations as published on July 1, 2001. Below is a list of the new standards in the federal regulations that are being incorporated into the regulations by reference.

1. 40 CFR Part 60 - Standards of performance for new stationary sources (new standards in new edition are listed below).

a. Subpart AAAA, Small Municipal Waste Combustors (40 CFR 60.1000 through 40 CFR 60.1465).

b. Subpart CCCC, Commercial/Industrial Solid Waste Incinerators (40 CFR 60.2000 through 40 CFR 60.2265).

2. 40 CFR Part 61 - National emissions standards for hazardous air pollutants -No new NESHAP are being incorporated; however, the date of the Code of Federal Regulations book being incorporated by reference is being updated to the latest version.

3. 40 CFR Part 63 - National emissions standards for hazardous air pollutants for source categories (new standards in new edition are listed below).

a. Subpart MM - Chemical Recovery Combustion Sources at Kraft, Soda, Sulfite and Stand-Alone Semichemical Pulp Mills 40 CFR 63.860 through 63.868).

b. Subpart CCCC - Manufacturing of Nutritional Yeast (40 CFR 63.2130 through 40 CFR 63.2192)

c. Subpart GGGG - Solvent Extraction for Vegetable Oil Production (40 CFR 63.2830 through 40 CFR 63.2872).

Statement of Final Agency Action

On November 7, 2001, the State Air Pollution Control Board adopted final amendments to regulations entitled "Regulations for the Control and Abatement of Air Pollution", specifically federal regulations incorporated by reference (9 VAC 5 Chapter 50, Article 5 and 9 VAC 5 Chapter 60, Articles 1 and 2). The regulation amendments are to be effective on February 1, 2002.

In adopting these amendments, the Board affirmed that it will receive, consider and respond to petitions by any person at any time with respect to reconsideration or revision, as provided in § 2.2-4006 B of the Administrative Process Act.

Letters providing written assurance from the Office of the Attorney General that (i) the Board has statutory authority to promulgate the final regulation amendments and (ii) the amendments qualify as an exemption under § 2.2-4006 A 4 c of the Administrative Process Act are available upon request.
