The Board has made a regulatory change which is exempt from provisions of the Administrative Process Act. In order to reduce an accumulated surplus in the budget of the Board of Counseling, a one-time reduction in renewal fees has been adopted for the renewal due June 30, 2010. The renewal fees for licensed professional counselors, marriage and family therapists, and substance

abuse treatment practitioners will be reduced for the annual renewal from \$105 to \$52. The renewal fee for certified substance abuse counselors and certified rehabilitation providers will be reduced from \$55 to \$27, and for substance abuse counseling assistants from \$40 to \$20.
