# Notice of Intended Regulatory Action (NOIRA) Agency Background Document

## Purpose

On August 2. 2007, Judge Walter D. Kelley, Jr., of the United States District Court for the Eastern District of Virginia entered a preliminary injunction, enjoining the Alcoholic Beverage Control Board and its agents from enforcing that portions of § 4.1-225of the Code of Virginia which prohibits alcoholic beverage licensees from allowing noisy conduct on licensed premises in Virginia. With enforcement of this Code section enjoined, the board has no provision of law or regulation to address noise issues on licensed premises. The judge found that the term "noisy" as used in the statute was unconstitutionally vague. The purpose of this action is to more clearly define the noise levels allowable on premises licensed for the sale of alcoholic beverages.

Title 4.1 of the Code of Virginia gives the Alcoholic Beverage Control Board general authority to regulate

the manufacture, distribution and sale of alcoholic beverages within the Commonwealth, including the authority to promulgate regulations which it deems necessary to carry out the provisions of Title 4.1, in accordance with the Administrative Process Act. The Code mandates that the Board promulgate regulations, but details are left to the Board's discretion.

#### Need

Please detail the specific reasons why the agency has determined that the proposed regulatory action is essential to protect the health, safety, or welfare of citizens. In addition, delineate any potential issues that may need to be addressed as the regulation is developed.

Establishments licensed for the sale of alcoholic beverages often generate a great deal of noise, from the combined voices of patrons to amplified musical entertainment. This sound can impact nearby residences or businesses, and have a damaging effect on the quality of life and the health of persons subjected to excessive sound levels. The agency has determined that sound levels emanating from licensed businesses must be controlled to protect the peace and tranquility of surrounding neighborhoods, and the health of citizens. Issues which need to be addressed as the regulation is developed include acceptable sound levels at various types of affected properties, methods of measurement, and possible exemptions for emergency or unavoidable temporary sound levels.

#### Substance

The agency intends to adopt a new regulation, providing that no licensee shall cause or permit noise on the licensed premises so as to create a sound pressure level which exceeds the limits set forth in the regulation, when measured at a receiving property. The regulation would establish maximum decibel levels for sound impacting residential, commercial, or industrial properties.

## Alternatives

The agency has considered and will consider taking no action or leaving noise control to regulation by local ordinances. Consideration will be given to the possible benefits of uniform statewide regulation versus varying local systems.
