As specified in Va. Code § 54.1-3443, the Board of Pharmacy, in consultation with the Virginia Department of Forensic Science ("DFS") has identified four (4) compounds for placement into Schedule I in the Virginia Administrative Code. The placement by regulatory action will remain in effect for 18 months or until the compounds are placed in Schedule I by legislative action of the General Assembly. This action is exempt in accordance with Va. Code § 2.2-4006 of the Virginia Administrative Process Act.

The impetus of this action is identification by DFS of four compounds which DFS recommends be included in Schedule I under the Virginia Administrative Code pursuant to Va. Code § 54.1-3443(D).

On June 25, 2024, the Board of Pharmacy amended 18VAC110-20-322 of the Regulations Governing the Practice of Pharmacy to place chemicals specified by DFS into Schedule I in accordance with Va. Code § 54.1-3443(D).
