Pursuant to <u>Chapter 183 of the 2023 Acts of Assembly</u>, the Board of Pharmacy amended certain provisions of 18VAC110-30 to change references to "nurse practitioners" to "advanced practice registered nurses."

On September 26, 2023, the Board of Pharmacy voted to amend the Regulations for Practitioners of the Healing Arts to Sell Controlled Substances by fast-track action.

Mandate and Impetus

The mandate for this action comes from <u>Chapter 183 of the 2023 Acts of Assembly</u>, which changed all references (including definitions) in the Code of Virginia from nurse practitioner to advanced practice registered nurse.

This change is non-controversial and appropriate for a fast-track action because it is merely a name change consistent with a statutory change. There are no substantive changes in this action and no impact on practitioners.

Regulations of the Board of Pharmacy are promulgated under the general authority of Chapter 24 of Title 54.1 of the Code of Virginia. Virginia Code § 54.1-2400(6) specifically states that the general powers and duties of health regulatory boards shall be "[t]o promulgate regulations in accordance with the Administrative Process Act (§ 2.2-4000 et seq.) that are reasonable and necessary to administer effectively the regulatory system."

The rationale for this change is to bring regulatory language in line with Code language. The regulatory change is needed to ensure clarity in the regulations, particularly since the term "nurse practitioner" is still used but is a *type* of APRN. The goal and problems the action is intended to solve is to alleviate that potential confusion and create conformity in the regulatory system by using the appropriate term for APRNs.

18VAC110-30-10, 18VAC110-30-20, and 18VAC110-30-270 are amended to change "nurse practitioner" references to "advanced practice registered nurse."

The promulgated regulations do not conflict with the purpose or intent of Chapters 1 or 25 of Title 54.1.
