On September 27, 2022, the Board of Psychology amended the Regulations Governing the Practice of Psychology by fast-track regulatory action.

### **Mandate and Impetus**

The impetus for this action is the Board's desire to ensure more individuals can apply for licensure as a clinical psychologist in Virginia. This action should be noncontroversial because it reduces barriers to licensure.

Regulations of the Board of Psychology are promulgated under the general authority of Chapter 24 of Title 54.1 of the Code of Virginia. Virginia Code § 54.1-2400(6) specifically states that the general powers and duties of health regulatory boards shall be "[t]o promulgate regulations in accordance with the Administrative Process Act (§ 2.2-4000 et seq.) that are reasonable and necessary to administer effectively the regulatory system."

These changes allow school psychologists who have obtained a doctorate to obtain a license in clinical psychology in Virginia. Additionally, the changes allow a resident studying school psychology to be supervised by a clinical psychologists.

(D) is amended to include individuals graduating from school psychology programs for the reasons stated above. In addition, counseling psychology programs are added to (D). Counseling programs should have been added at the same time counseling programs were added to (A), but the change was overlooked. Counseling psychology programs are added to (D) to comport with (A).
20-65(B)(6)	Requires supervision of residents in psychology to be provided by an individual licensed in the category in which the resident is seeking licensure.	Currently, a school psychologist may only be supervised during residency by another school psychologist. The Board has changed the language of (B)(6) to allow school psychologists to be supervised by clinical psychologists, which provides a greater number of potential supervisors than simply school psychologists. There are currently 100 licensed school psychologists and 4,418 licensed clinical psychologists in Virginia.  The Board did not remove the limitation on license type for supervision in its entirety because applied psychologists and school psychologists without a doctorate would not be appropriate residency supervisors for residents applying for licensure as a clinical psychologist.
