The amendments will reduce the fee for initial licensure and for annual renewal of licensure for licensed baccalaureate social workers. The application fee is reduced from \$115 to \$100, and the renewal fee is reduced from \$65 to \$55. The most significant reduction in regulatory burden is the elimination of the current requirement for an applicant with a baccalaureate degree to have 3,000 hours of supervised experience in order to qualify for licensure as a LBSW.

On September 20, 2019, the Board of Social Work amended 18VAC140-20-10 et seq., Regulations Governing the Practice of Social Work.

Mandate and Impetus

The impetus was consideration by the Board of changes that could increase the numbers of LBSWs and increase the workforce able to provide social work services. The rulemaking will make licensure as a LBSW considerably less burdensome, is consistent with 35 other states, and is not expected to be controversial.

Regulations are promulgated under the general authority of Chapter 24 of Title 54.1 of the Code of Virginia. Section 54.1-2400 (6), which provides the Board of Social Work the authority to promulgate regulations to administer the regulatory system:

§ 54.1-2400 -General powers and duties of health regulatory boards

The general powers and duties of health regulatory boards shall be:...

1. To establish the qualifications for registration, certification, licensure, permit, or the issuance of a multistate licensure privilege in accordance with the applicable law which are necessary to ensure competence and integrity to engage in the regulated professions.

2. To examine or cause to be examined applicants for certification, licensure, or registration. Unless otherwise required by law, examinations shall be administered in writing or shall be a demonstration of manual skills.

- 3. To register, certify, license, or issue a multistate licensure privilege to qualified applicants as practitioners of the particular profession or professions regulated by such board.
- 4. To establish schedules for renewals of registration, certification, licensure, permit, and the issuance of a multistate licensure privilege.
- 5. To levy and collect fees for application processing, examination, registration, certification or licensure or the issuance of a multistate licensure privilege and renewal that are sufficient to cover all expenses for the administration and operation of the Department of Health Professions, the Board of Health Professions and the health regulatory boards.
- 6. To promulgate regulations in accordance with the Administrative Process Act (§ 2.2-4000 et seq.) which are reasonable and necessary to administer effectively the regulatory system. Such regulations shall not conflict with the purposes and intent of this chapter or of Chapter 1 (§ 54.1-100 et seq.) and Chapter 25 (§ 54.1-2500 et seq.) of this title. ...

Purpose

The less burdensome and costly pathway to licensed for persons with a bachelor's degree in social work may encourage some to seek licensure. Additional persons in the social work field provided support services and casework may increase access to mental health services and help protect the public health, safety and welfare.

The amendments will reduce the fee for initial licensure and for annual renewal of licensure for licensed baccalaureate social workers. The application fee is reduced from \$115 to \$100, and the renewal fee is reduced from \$65 to \$55. The most significant reduction in regulatory burden is the elimination of the current requirement for an applicant with a baccalaureate degree to have 3,000 hours of supervised experience in order to qualify for licensure as a LBSW.

persons working as LBSWs, providing casework and related services, if the cost
reduction and elimination of supervised experience leads to an increase in the number of
licensed providers.

- 2) There are no advantages or disadvantages to the agency; with only 13 persons currently licensed as LBSWs, the \$10 reduction in renewal fees will not affect the Board's budget.
- 3) The Director of the Department of Health Professions has reviewed the proposal and performed a competitive impact analysis. The Board is authorized under 54.1-2400 to "promulgate regulations in accordance with the Administrative Process Act (§ 2.2-4000 et seq. which are reasonable and necessary to administer effectively the regulatory system." There is no restraint on competition resulting from this regulation as it is less burdensome and less restrictive.

Benefits the regulatory change is designed to produce.	There will be cost reduction for applicants for a LBSW of \$15 and an annual reduction of \$10. The elimination of 3,000 hours of supervised experience will enable a person with a baccalaureate degree from an accredited school of social work to be licensed 18 months to two years earlier, which will improve employment opportunities and income.

In order to reduce application and renewal fees for a licensure category, regulations must be amended. Elimination of an experience requirement for licensure is a less intrusive and less costly alternative.

Detail of Changes

18VAC140- 20-30	Establishes fees charged to applicants and licensees	The application fee for a LBSW is reduced from \$115 to \$100, and the renewal fee for a LBSW is reduced from \$65 to \$55. The modest reduction is appropriate to distinguish between an LBSW and an LMSW. The LBSW has a less comprehensive scope of practice and is required to work under supervision of an LMSW. Until legislation was passed in 2018, persons with a bachelor's degree and a master's degree qualified for the same license – licensed social worker. With the separation into two different licenses, the distinction between the two should be recognized by a distinction in fees.
18VAC140- 20-60	Sets out the educational and experience required for an LBSW and an LMSW	Subsections C and D are deleted to eliminate all of the requirements related to the 3,000 hours of supervised experience in the current regulations for licensure as an LBSW. Subsection B is also deleted because it states that a master's prepared applicant is not required to have supervised experience to obtain a license as an LMSW. With the elimination of experience requirements for the LBSW, the distinction with the LMSW is not necessary, so the section is retitled as "Education requirements for an LBSW or LMSW." In § 54.1-3700 of the Code of Virginia, a baccalaureate social worker means "a person who engages in the practice of social work under the supervision of a master's social worker and provides basic generalist services, including casework management and supportive services and consultation and education."

While the provision of basic generalist services, casework, etc. does require training and experience, a baccalaureate degree social worker must learn how to provide services appropriate to the work setting in which he is employed under the supervision of a master's social worker. An LBSW continues to work under supervision, so a 3,000-hours supervised experience is unnecessary for licensure. A survey of requirements in other states found that 35 states do not require supervised experience following the bachelor's degree; twelve states have no comparable license type; and four states (including Virginia) require supervised experience hours for licensure. The Board found no compelling reasons to retain the requirement, which is a substantial burden and a deterrent to licensure as an LBSW.
