Section 50:

The amendment clarifies that the regulation allows for the purchase of new riparian stationary waterfowl blind licenses on shore in the City of Virginia Beach.

Section 50:

The intent of this regulation was to prevent new stationary blinds from being licensed in the public waters in the City of Virginia Beach and not to prevent new stationary blinds from being licensed on land. The amendment aligns the regulation with Code of Virginia 29.1-340. This is a clarification of an allowance that was previously unclear.
