1VAC30-41 establishes the requirements for certification of drinking water laboratories. 1VAC30-41-55 incorporates by reference the sampling, analytical methodology, and laboratory certification requirements of 40 CFR Part 141 and 40 CFR Part 143 into 1VAC30-41. 1VAC30-41-55 currently includes these Code of Federal Regulation (CFR) requirements through July 1, 2018.

This exempt action updates this incorporation by reference of the CFR through July 1, 2023. During this period the U.S. Environmental Protection Agency (EPA) published three expedited alternative analytical test method lists. Alternative analytical test methods do not impose new requirements. EPA approves these test methods as equivalent to methods that EPA already requires laboratories to use. Recently

EPA approved additional alternative test methods. These were published in the Federal Register on January 30, 2024, and corrected in the Federal Register on February 5, 2024. This exempt action also incorporates by reference these additional alternative test methods.

Mandate and Impetus

The U.S. Environmental Protection Agency requires certified drinking water laboratories to use federally approved analytical test methods. These analytical test methods are promulgated in 40 CFR 141 and 143 in the Federal Register and then compiled in the Code of Federal Regulations each July 1st. This action updates the incorporation by reference of these federal requirements. Section 2.2-4006 A 4(c) of the Administrative Process Act provides that the Department may adopt these regulatory amendments as a final exempt action because the changes are necessary to conform to changes in the federal regulations. The Department of General Services, Division of Consolidated Laboratory Services has the authority to carry out certification of drinking water laboratories in Virginia under §§ 2.2-1102 and 2.2-1105 of the Code of Virginia.

The Director of the Department of General Services approved the revised regulation on May 21, 2024. The title of the regulation is **Regulation for the Certification of Laboratories Analyzing Drinking Water**.
