Regulations are necessary to ensure children are protected to the extent possible from vaccine-preventable diseases and to indirectly protect the health of all citizens of Virginia. Legislation enacted by the 2006 Virginia General Assembly requires the regulations to be updated to reflect current immunization recommendations and also added two new required vaccines. Legislation enacted by the 2007 Virginia General Assembly added an additional new vaccine requirement. The regulations must be amended to bring them into conformance with the new legislation and with any legislation that may be introduced in 2008.

#### Substance

Amendments to the current regulations will:

- Update and clarify definitions;
