#### Purpose

The regulatory action is to update the regulation to incorporate by reference the newest available nationally recognized model building codes and standards produced by ICC. The ICC International Building Code (IBC), the ICC International Existing Building Code (IEBC), the International Residential Code (IRC) and the International Property Maintenance Code (IPMC) are the major model codes. The IBC further references the ICC mechanical, plumbing, gas codes and the National Electrical Code. The ICC codes are known collectively as the "I-Codes."

In conjunction with incorporating the newest available I-Codes into the regulation, the entire regulation will be subject to review and change. This is due to the fact that the I-Codes constitute the majority of the regulation and the various parts of the regulation must be coordinated with the use of the I-Codes which necessitates scrutiny of the entire regulation.

This action is exempt from Article 2 of the Administrative Process Act under § 2.2-4406(13) of the Code of Virginia.

The enabling law for the USBC requires the Board to keep the regulation up to date. The newest model codes become available every three years, so when they become available, the Board initiates a regulatory action to update the USBC to include them. The newest I-Codes are the 2012 editions, which became available in late 2011. The current USBC uses the 2009 editions of the I-Codes.

The proposed regulation will update all references to the I-Codes from the 2009 to the 2012 editions. The proposed regulation will also contain minor changes to the I-Codes or to the associated administrative provisions of the regulation which have been vetted through the client groups affected by the USBC and have met no opposition.
