The Statewide Fire Prevention Code (SFPC) is a regulation governing the maintenance of the fire protection aspects of existing structures and operational functions relating to fire safety wherever located, including the regulation of the use of explosives and blasting and fireworks displays. The SFPC uses a nationally recognized model code produced by the International Code Council as the basis for the technical provisions of the regulation. Every three years, a new edition of the model code becomes available. At that time, the BHCD initiates a regulatory action to incorporate the newest edition of the model code into the regulation as well as accepting proposals for changes to the regulation from affected client groups and the public. The Department of Housing and Community Development staff maintains mailing lists for workgroups involving different subject areas of regulation and conducts workgroup meetings attended by clients group participants to develop consensus recommendations, when possible, concerning proposals which have been submitted. The Department uses an online program incorporating the provisions of the regulation and the model code to facilitate the submittal of proposals. A public hearing is held during the workgroup meeting stage of the process and a comment period established.

Once workgroup meetings are completed, the BHCD has a series of meetings to consider each proposal and those proposals approved are incorporated into the proposed regulation. After the publishing of the proposed regulation, the BHCD establishes a comment period for additional proposals to be submitted and to comment on the proposed regulation and an additional public hearing is held. The BHCD then meets to consider proposals and public comments to develop a final regulation to complete the regulatory process.

Several updates throughout the SFPC to change references to "applicable building code" to the specific chapter, NFPA or other standard.

13VAC5-51-130

Update definition for "Corrosive" to include specific pH values.

Add a definition for "permissible fireworks".

Add a definition for "emergency supplemental hardware"

13VAC5-51-131

Change to restrict combustible storage under bridges and along roadways.

13VAC5-51-132

Add provisions and parameters to allow the use of emergency supplemental hardware.

13VAC5-51-135.5

Removes language that says security devices are subject to approval by the fire official; requires permit under the Uniform Statewide Building Code.

13VAC5-51-138.4

Updated the section for foam protection for rooftop heliports.

13VAC5-51-138.8

Several updates to reference the specific chapter and NFPA standard instead of using the blanket terminology "applicable building code."

Add section for Type II systems in Dry cleaning operations and fire-fighting access for such.

13VAC5-51-140

Many changes to the sections for dispensing operations and dispensing devices to add provisions for disconnect switches and fuel shot off parameters

Added provisions for special containers and enclosures.

Added a section for Repair garages for lighter than air fuels (CNG, LNG, hydrogen).

Added provisions and updated the sections for spray booths, spray applications and the ventilation requirements for such.

Updated dip-tank operations sections and the volumetric limitations and provisions pertaining to each level of liquid capacity.

13VAC5-51-141

Updated the requirements for ethylene generator rooms and the air circulation requirements.

13VAC5-51-142.5

Updated the requirements for dust control, explosion venting and the storage and removal of waste from lumber yards and other woodworking facilities.

13VAC5-51-143.5

Added restrictions for nitrocellulose in mills.

13VAC5-51-144

Added back in a section for manual fuel shutoff valves.

13VAC5-51-144.2

Added "temporary special event structures" to scoping section and added size and square footage restrictions for tents and other membrane structures. Also added a list of documents required to be submitted with an operational permit for membrane structures.

13VAC5-51-144.4

Added requirements for a "high-piled storage operational plan";

13VAC5-51-144.6

Added back in a section to locate buffing operations in a separate part of the building in which tire rebuilding occurs.

13VAC5-51-145

Added a new term "permissible fireworks" to Table 5003.1.1(1) and changed the quantities allowable for such.

13VAC5-51-146.5

Added sections for compressed gas storage and protections against dangers related to such.

Section 27-97 of the Code of Virginia empowers the Board to promulgate the SFPC. In adopting the SFPC the Code states that the, "Board shall have due regard for generally accepted standards as recommended by nationally recognized organizations including, but not limited to, standards of the International Code Council, the National Fire Protection Association, and recognized organizations issuing standards for the protection of the public from the hazards of explosives and blasting agents. Such standards shall be based on the companion document to the model building code referenced by the Uniform Statewide Building Code." The SFPC and USBC use nationally recognized model building codes and standards produced by the International Code Council (ICC) and other standard-writing groups as the basis for the technical provisions of the regulation. Every three years, new editions of the model codes become available. At that time, the BHCD initiates a regulatory action to incorporate the newest editions of the model codes into the regulation as well as accepting proposals for changes to the regulation from affected client groups and the public.

- 1) The regulation ensures the proper and safe maintenance of structures in Virginia as related to fire safety.
- 2) There were limited, specific, comments submitted during the Periodic Review/NOIRA comment period. The comments were not submitted as a result of the Notice of Periodic Review of Regulation or NOIRA but rather as a result of a regulatory concern that occurred during that timeframe. Staff responded to each comment with additional information about opportunities for public comment and the process for initiating code changes. The comments were also forwarded to the Board.

- 4) The regulation does not appear to overlap with state or federal law or regulation.
- 5) The regulation was last evaluated and updated in 2018.
