This regulatory action amends the Virginia Administrative Code to include Licensed Behavioral Analysts (LBAs) in the definition of the term “Credentialed Addiction Treatment Professional” as required by legislation from the 2024 General Assembly. LBAs are currently included in the definition of a “Licensed Mental Health Professional”. The Medicaid provider community has asked that LBAs also be included in the definition of a “Credentialed Addiction Treatment Professional”, as substance use disorder (SUD) treatment is a subspecialty of behavioral analysis and LBAs may provide SUD services within the scope of their Board of Medicine license. Adding LBAs to the definition of a “Credentialed Addiction Treatment Professional” also

represents an effort to address the shortage of available credentialed addiction treatment professionals in Virginia.

Virginia submitted a state plan amendment (SPA) to obtain federal approval to make this change. The SPA was approved on September 11, 2024 ([link](#)).

On February 4, 2025, the Department of Medical Assistance Services adopted final amendments to the regulatory action entitled, “Licensed Behavior Analysts to be Credentialed Addiction Treatment Professionals.”

House Bill 503 from the 2024 General Assembly session required DMAS to make this change.

These regulatory changes are expected to be non-controversial because they align with current behavioral health practices.

The Code of Virginia § 32.1-325, grants to the Board of Medical Assistance Services the authority to administer and amend the Plan for Medical Assistance and to promulgate regulations. House Bill 503 from the 2024 General Assembly session required DMAS to make this change.

This regulatory action is needed to add Licensed Behavior Analysts to the definition of Credentialed Addiction Treatment Professional consistent with the State Plan.

The changes are essential to the health, safety, and welfare of Medicaid recipients because they ensure that the regulations permit appropriate practitioner types to provide behavioral health services.

The goal of the regulatory change is to ensure that the regulations accurately reflect the types of providers approved to provide services under the Addiction and Recovery Treatment Services (ARTS) program available to Medicaid members.

This regulatory action amends the Virginia Administrative Code to reflect the approval of the State Plan Amendment expanding the definition of Credentialed Addiction Treatment

Professionals for services in the Addiction Recovery Treatment Services (ARTS) program to include Licensed Behavior Analysts (LBA).

This regulatory action reflects the inclusion of Licensed Behavior Analysts (LBA) as providers for services in the ARTS program.

Issues

A primary advantage of this change is to expand access to the Addiction and Recovery Treatment Services program by adding Licensed Behavior Analysts (LBA) to the list of approved providers for Medicaid recipients. Increased access to these important services can lead to better health outcomes.

These changes create no disadvantages to the public, the Agency, the Commonwealth, or the regulated community.

There are no alternatives that would achieve the goal of adding Licensed Behavior Analysts (LBA) to the defined list of providers known as Credentialed Addiction Treatment Professionals in accordance with the State Plan and the mandate from HB 503 from the 2024 General Assembly.

No alternatives can achieve the objective updating the regulations to match the State Plan and accurately reflect the addition of Licensed Behavior Analysts to the definition of Credentialed Addiction Treatment Professionals in accordance with the State Plan and the mandate from HB503 from the 2024 General Assembly.
