This regulation provides procedures to protect human life and property from the unsafe or dangerous construction, installation, inspection, operation, and repair of boilers and pressure vessels in the Commonwealth of Virginia.

Amendments are necessary to decrease the frequency of inspections for certain pressure vessels to more practical limits without affecting safety. In order to take advantage of the latest technology available, the references to national standards should be updated to current. Other housekeeping changes are updated to facilitate electronic reporting.

The regulation is mandated by Sections 40.1-51.6 through 40.1-51.10 of the Code of Virginia. The scope of the mandate is that "no boiler or pressure vessel which does not conform to the rules and regulations of the (Safety and Health Codes) Board governing new construction and installation and which has been certified by the Board shall be installed or operated in this Commonwealth after twelve months from July 1, 1973."

#### **Substance**

The following amendments are being proposed:

- 1. Delete subparagraph G (Hobby boiler) in 16 VAC 25-50-20. Reason for the change is to eliminate possible conflicts with the recently enacted statute (Section 40.1-51.19) covering hobby boilers.
- Change inspection frequency of air compressor tanks in 16 VAC 25-50-30 from two (2) to three (3) years. Change inspection frequency of certain non-toxic pressure vessels from two (2) to five (5) years. Updating frequencies to be similar to 11 other jurisdictions satisfies new risk assessment strategies.
- 3. Allow use of credit cards in 16 VAC 25-50-150 which will facilitate the use of electronic reporting and allow DOLI to receive payments sooner.
- 4. Delete reference of obsolete ASME Code Section VII in 16 VAC 25-50-330.
- 5. Adopt Part CW (Steam and Waterside Control) of CSD-1-1998 to replace a reference to CSD-1 1992 in 16 VAC 25-50-340 and 16 VAC 25-50-440. This national standard contains provisions for improving the safe operation of steam boilers and pressure vessels by requiring redundant controls with manual resets on new installations.
- 6. Update references to 2001 editions of the NFPA 85 Boiler and Combustion Systems Hazards Code, ASME Code and National Board Inspection Code to take advantage of the latest technical advances in safety.

#### **Alternatives**

Because the regulation is mandated by the Code of Virginia, no viable alternatives exist. The agency will consider comments from affected citizens during the regulatory process.
