Pursuant to <u>§ 22.1-289.03 of the Code of Virginia</u>, the Board of Education (Board) is responsible for establishing "a statewide unified public-private system for early childhood care and education system in the Commonwealth to ensure that every child has the opportunity to enter kindergarten healthy and ready to learn." The system will be "implemented by the Board, the Superintendent [of Public Instruction] and the Department [of Education (VDOE)]" effective July 1, 2021. Funding and oversight of early childhood care and education (ECCE) programs and policies—including the Child Care Subsidy Program and child care licensing and monitoring will transition to VDOE from the Virginia Department of Social Services on July 1 accordingly.

Chapters <u>860</u> and <u>861</u> of the 2020 Acts of the General Assembly require that the regulations governing the implementation and oversight of ECCE programs be transferred from the Board of Social Services to the Board and state that such transferred regulations "remain in full force and effect until altered, amended, or rescinded by the Board of Education." The Board's initial actions to adopt these regulations with "necessary amendments" are exempt from Article 2 (4 <u>2.2-4006 et seq</u>.) of Chapter 40 of Title 2.2 of the Code of Virginia. Necessary amendments for the purposes of such exempt action include:

- Renumbering;
- Changing references from the Board of Social Services to the Board of Education;
- Changing code references and descriptions;
- Striking regulations specific to adult care programs and child welfare programs; and
- Striking regulations related to child support enforcement pursuant to <u>§ 63.2-</u> <u>1911</u>.

## **Mandate and Impetus**

Chapters <u>860</u> and <u>861</u> of the 2020 Acts of the General Assembly require that the regulations governing the implementation and oversight of ECCE programs be transferred from the Board of Social Services to the Board of Education.
