	confidentiality, safety, and privacy.

	Direct Benefits: DBHDS guidance documents are not enforceable, and		
	therefore, this change will not result in any direct benefits for providers,		

(2) Present	as there is no change to the underlying regulation regarding requirements for providers to assure privacy and confidentiality for individuals while ensuring a safe and therapeutic treatment environment. This guidance document is expected to reduce unnecessary administrative processes by clarifying that when (i) monitoring devices are positioned in common areas and (ii) the protections referenced in regulation have been addressed in a provider's policy and procedures, then the use of monitoring devices does not require review by a local human rights committee. Additionally, guidance may help individuals by clarifying that processes established for monitoring cannot be used to diminish or substitute for provider staff responsibilities specific to supervision and support of individuals receiving services.
