May 13, 2024 the Motor Vehicle Dealer Board approved the periodic review and continuation of this regulation. We received no complaints or comments regarding the need to repeal or amend this regulation, and the regulation is written clearly and is easy to understand. This regulation does not overlap, duplicate, or conflict with any federal or state law or regulation. This regulation was amended and reviewed on 09/10/2014 to amend the 2014 General Assembly "Omnibus" MVDB bill. One of the features of this 2014 bill was to authorize the Board to set most fees up to the limits allowed in Virginia Code without the need to adopt regulations. The only fees that were not included in the 2014 legislation are the registration fees for dealer license plates, which are spelled out specifically in the Code.
