Below you will find sample MACT placeholder conditions. These conditions are not boilerplate conditions. These are examples that can be used in Title V permits. These are intended to be generic. These conditions can be modified in any manner necessary to meet the needs of the permit. This list does not preclude any permit writer from being more specific.

Process Emissions Requirement

Except where this permit is more restrictive, on {compliance date if not passed} the {emission unit or process description} shall comply with the {control or operational} requirements of {List name of MACT} 40 CFR Part 63 Subpart {XXX}.

(9 VAC 5-60-90, 9 VAC 5-60-100, 9 VAC 5-80-110 and 40 CFR 63 subpart XXX)

Monitoring

Except where this permit is more restrictive, on {list the compliance date if it has not passed} the permittee shall meet all monitoring requirements of 40 CFR 63 subpart {XXX} {List MACT NAME} applicable to the {list emission unit or process description}. The monitors shall be maintained and operated in accordance with 40 CFR 63 subpart {XXXX}. {These requirements include the following:

Recordkeeping

Except where this permit is more restrictive, on {list the compliance date if it has not passed} the permittee in accordance with 40 CFR 63 subpart {XXX} {list MACT NAME} shall record and retain all information necessary to determine that the operation of the {emissions unit or process description} is in compliance with the 40 CFR 63 subpart {XXXX}. {These requirements include the following:

Reporting Requirements

Except where this permit is more restrictive, on {list the compliance date if it has not passed} the permittee in accordance with 40 CFR 63 subpart {XXX} {list MACT NAME} shall meet all applicable reporting requirements to {emissions unit or process description}. These requirements include the following:

Testing Requirements

The permittee shall conduct all testing required in 40 CFR 63 subpart {XXX} {list MACT NAME}. {These requirements include the following:

Other Sample Conditions:
