VOSH PROGRAM DIRECTIVE: 12-013

ISSUED: April 1, 2003

SUBJECT: Exit Routes, Emergency Action Plans, and Fire Prevention Plans, §§1910.33 through 1910.39, Subpart E; Final Rule and Changes to Related Standards

A. Purpose.

This directive transmits to field personnel the General Industry revised final rule for exit routes, emergency action plans, and fire prevention plans, §§1910.33 through 1910.39 and changes to related standards.

This Program Directive is an internal guideline, not a statutory or regulatory rule, and is intended to provide instructions to VOSH personnel regarding internal operation of the Virginia Occupational Safety and Health Program and is solely for the benefit of the program. This document is not subject to the Virginia Register Act or the Administrative Process Act; it does not have general application and is not being enforced as having the force of law.

B. Scope.

This directive applies to all VOSH personnel.

E. Action.

Directors and Managers shall ensure that field personnel understand and comply with the revised standard included in this directive.

F. Effective Date.

March 1, 2003

G. Expiration Date.

H. Background.

The goal of OSHA's revision of Subpart E was to maintain the level of safety and health protection provided to employees under the existing rule, without increasing the regulatory burden on employers. In addition, OSHA sought to create a regulation that was easily understood and, to the extent possible, express employers' obligations in performance-oriented language. This revision of Subpart E rewrites the existing requirements in clearer language so that they will be easier to understand by employers, employees, and others who use them. This change reorganizes the text, removes inconsistencies among sections, and eliminates duplicative requirements.

I. Summary.

The Occupational Safety and Health Administration (OSHA) has revised its standard for means of egress. The revised final rules are performance-oriented to the extent possible, and more concise than the original, with fewer subparagraphs, and fewer cross-references to other OSHA standards. A table of contents has also been added to make the standards easier to use.

In addition, compliance by an employer with National Fire Protection Association, NFPA 101-2000, the Life Safety Code, will be deemed to be in compliance with the corresponding requirements of the revised standard. The name of Subpart E has also been changed from "Means of Egress" to "Exit Routes, Emergency Action Plans and Fire Prevention Plans" to more accurately reflect the full content of the Subpart.
