Legislation Impacting Foster Care Program Effective May 1, 2023.

The purpose of this broadcast is to share with the Local Departments of Social Services (LDSS) the form necessary to implement legislation impacting the Foster Care Program that goes into effect **May 1, 2023**. This is not a typical enactment date due to the senate not having officially adjourned during the 2022 special session. Bills that were part of the special session could not be enacted until 4 months following the adjournment which took place when the senate convened for the 2023 regular session.

HB 349 of the 2022 General Assembly session directs LDSS to provide housing support for youth who turned 18 in foster care on or after July 1, 2022 and are not participating in the Fostering Futures Program. Youth between the ages of 18 and 21 are eligible for up to six months of support, consecutive or non-consecutive. The payment is equal to the room and board portion of the current maintenance payment for youth age 13 and over.

HOUSING SUPPORT FOR EMANCIPATED YOUTH COMMUNICATION FORM

Form Instructions:

Beginning May 1, 2023, youth who may be eligible for Fostering Futures, but are not participating in Fostering Futures at any point between the ages of 18 and 21, may be eligible for time-limited housing support. The housing support assistance is equal to the room and board portion of the maintenance payment for Fostering Futures. A youth may receive this support for a period of no more than six months (consecutive or non-consecutive) from the age of 18 until their 21st birthday. This communication form should be used to document the youth's eligibility, participation, and termination in the program when applicable.

The youth's caseworker should notify the youth prior to turning 18 in foster care of this resource. The youth's caseworker needs to include information about this program in the youth's transition plan. A youth may receive this support for a period of no more than six months (consecutive or non-consecutive) from the age of 18 until their 21st birthday. Youth may take advantage of the assistance at any point between the ages of 18 and 21, so long as they have not received the maximum amount of six months of assistance.

While the implementation date of this program is May 1, 2023, the law applies to youth who turned 18 on or after July 1, 2022. The LDSS will need to notify youth who meet the criteria of their right to enroll in this program.

Applications and Payments:

If a youth chooses to receive housing support, the youth's service worker must provide them with a copy of the Housing Support Communication Form. The worker needs to obtain the information from the youth and complete the checklist below to facilitate the youth's participation in the program.

Within 10 calendar days of completion of the form, the service worker will confirm that the youth meets the eligibility criteria outlined above through the child welfare information system.

The worker must indicate that the youth is eligible on the form and provide a copy to the youth. If eligible, payments must be issued in monthly increments from the housing support budget line on the first of the following month from their eligibility determination. Budget line 86901 has been designated for these additional funds made available by the Virginia General Assembly. The LDSS will need to submit a BRS request in LASER for reimbursement. The worker must ensure payments are documented in the child welfare information system.

Termination:

The youth's housing support payments must not be terminated unless:

- The youth requests for the payments to be terminated;
- The youth elects to enter Fostering Futures (the housing support payments may continue until the VCSSA has been executed);
- The worker does not have on file a forwarding address and has been unable to locate the youth in the past 60 days, during which time a 30-day notice of termination was sent to the last known address or contact information for the youth; or
- The youth has received the maximum allotment of six months of housing support.

Documentation:

The payments and contacts with the youth should be documented by the worker on the youth's closed foster care case in the child welfare information system on the IL screens. These screens remain accessible after case closure. The months of the payments that were issued should be entered on the IL services screen. Tip sheets on how to enter housing support payment information in the child welfare information system are posted on <u>FUSION</u>.
