An alternative for achieving the purpose of the existing regulation would be to attempt to enforce the provisions of this regulation via the general provisions of the Virginia Food Laws. However, enforcement of the specific requirements contained in the regulations via the Virginia Food Laws would be difficult and cumbersome. An additional alternative would be to incorporate portions of the regulations themselves into existing statutes in the Virginia Food Laws. However, the agency rejects this alternative as this process would require a significant expenditure of time and effort and would include specific sausage related provisions that are more suitably defined in regulation.

This regulation meets the criteria set out in Executive Order 14 (2010). The regulation is essential to protect the welfare of citizens in that observation alone will not disclose the amount of fat and other non-meat ingredients that are contained in sausage products. The regulation impacts the health of the citizens of the Commonwealth in that consumers who purchase sausage products will not consume a sausage product with a fat content higher than the maximum amount defined in the regulations. This regulation is clearly written and is easily understandable.

The agency believes there is a continued need for this regulation because the manufacturing of sausage at the retail level is still occurring and the regulation is needed to ensure that the product is processed according to established standards. The regulation is easily understandable and is not complex. The regulation parallels existing federal regulations but is primarily in place to regulate sausage retailers who are not typically regulated by existing federal or state meat-related regulatory requirements. This regulation is in harmony with and does not conflict with existing federal and state regulations. The last regulatory review for this regulation occurred in 2001. The equipment and technology utilized in making sausage at the retail level has seen minimal change since the last regulatory review. The agency has determined that the regulation should remain in place. The economic impact of the regulation on small businesses is minimal.

### Family impact

This regulation is necessary in order to assure consumers and families that the sausage products that they purchase do not contain excessive levels of fat. It also assures consumers and families that the sausage that they purchase does not contain excessive levels of non-meat ingredients. This regulation ensures that consumers and families have the opportunity to purchase sausage products that are not inferior and that meet their expectations. It should have a positive impact on the institution of the family and family stability.
