Regulations of the Board of Social Work are promulgated under the general authority of Chapter 24 of Title 54.1 of the Code of Virginia. Virginia Code § 54.1-2400(6) specifically states that the general powers and duties of health regulatory boards shall be "[t]o promulgate regulations in accordance with the

Administrative Process Act (§ 2.2-4000 et seq.) that are reasonable and necessary to administer effectively the regulatory system."

Licensed issued by the Board of Social Work and the practice of social work are mandated by the Code of Virginia. See Va. Code § 54.1-3700 *et seq*. There are no alternatives for implementation of the legislative mandates related to the practice of social work other than the promulgation of reasonable regulations that are enforceable and protect the public health and safety.

The Notice of Periodic Review was published in the Register on December 20, 2021. Public comment was requested until January 19, 2022, including whether the regulations (i) are necessary for the protection of public health, safety, and welfare or for the economic performance of important governmental functions; (ii) minimize the economic impact on small businesses in a manner consisted with the stated objectives of applicable law; and (iii) are clearly written and easily understandable. There are 138 persons on the Town Hall notification list for the Board of Social Work. There were no comments during the comment period.

Effectiveness

This chapter was in effect as VR620-01-2 before the creation of the Virginia Administrative Code. It has been amended 15 times in the last five years. By adoption of statutory mandates, the General Assembly concluded that licensure of social workers is essential for the protection of health and safety.

Decision

The Code of Virginia mandates licensure for social workers. Therefore, the regulatory chapter must be retained. The Board intends to publish a Notice of Intended Regulatory Action to clarify and simplify some requirements, and to specify certain unprofessional conduct seen in disciplinary hearings.

Small Business Impact

(1) There is a continued need for these regulations since the Code requires social workers to hold licenses issued by the Board.

(2) The Board has not received any complaints or comments concerning these regulations.

(3) Practitioners do not find these regulations overly complex, but the Board will consider whether requirements for licensure, renewal, and training could be simplified.

(4) There is no overlap, duplication, or conflict with federal or state law or regulation.

(5) This chapter has been amended 15 times in the last 5 years. In its review and rulemaking as a result of this periodic review, the Board will consider any possible amendments that will streamline or clarify regulations in order to minimize the economic impact on small businesses.
