Section 3.2-109 of the Code of Virginia (Code) establishes the Board of Agriculture and Consumer Services (Board) as a policy board and authorizes the Board to adopt regulations in accordance with the

provisions of Title 3.2 of the Code. Section 3.2-703 of the Code authorizes the Board to quarantine the Commonwealth or any portion thereof when it determines that such action is necessary to prevent or retard the spread of a pest into, within, or from the Commonwealth. Section 3.2-703 of the Code also authorizes the Commissioner of Agriculture and Consumer Services (Commissioner) to extend or reduce areas currently regulated for plant pests.

Alternatives to Regulation

Thousand Cankers Disease (TCD) is a disease complex that is carried by the Walnut Twig Beetle and impacts walnut trees. If a Walnut Twig Beetle attacks a walnut tree, it causes the tree to become infected with TCD, which eventually may kill the tree. The quarantine restricts the movement of these plants and plant parts in order to slow the spread of this disease. The agency has determined that these requirements are no longer necessary as TCD has spread minimally and has not had a major impact on walnut tree populations in Virginia since its original detection in Virginia in 2011. As the disease has not impacted walnut tree populations in Virginia, the quarantine established in this regulation is no longer needed.

The agency received no public comment in response to the Notice of Periodic Review published on August 15, 2022, and did not form an informal advisory group for the purpose of assisting in this periodic review.

Effectiveness

This regulation is no longer necessary for the protection of public health, safety, and welfare because TCD has only spread minimally and has not had a major impact on walnut tree populations in Virginia since its detection in 2011.

Decision

The agency has determined that it is now appropriate to repeal this regulation because TCD has only spread minimally and has not had a major impact on walnut tree populations in Virginia since its detection in 2011.

This regulation was promulgated to help prevent the artificial spread of TCD to uninfested areas of the Commonwealth by regulating the movement of the articles that are capable of transporting the disease. The agency has determined that this regulation should be repealed because TCD has only spread minimally and has not had a major impact on walnut tree populations in Virginia since its original detection in Virginia in 2011. As the disease is not spreading and has not had an impact on walnut trees in Virginia, the quarantine is unnecessary. The repeal of this regulation will eliminate any cost associated with compliance with the requirements established in the regulation.
