§ 3.2-4501 of the Code of Virginia mandates that the Board of Agriculture and Consumer services shall have the power to adopt reasonable rules and regulations for the enforcement of the law. It further mandates that the Board shall establish and promulgate from time to time official standard grades for apples by which the quality, quantity and size may be determined. It further mandates that the Board shall consult with the Board of Directors of the Virginia Horticultural Society before establishing such official standard grades. The regulation does not exceed the minimum requirements of the state mandates.

Alternatives

Please describe all viable alternatives for achieving the purpose of the existing regulation that have been considered as part of the periodic review process. Include an explanation of why such alternatives were rejected and why this regulation is the least burdensome alternative available for achieving the purpose of the regulation.

The Agency considered repealing the regulation, but it is mandated by the Code of Virginia and the Agency believes the present version is the least burdensome and least intrusive alternative. The regulation contains the Virginia Apple Standards that may be used as a marketing tool to obtain higher

prices and to assist growers in the sale of their apples. For these reasons, the Agency rejected the consideration to repeal the regulation.
