Mr. Kirschner advised the Board that the temporary waiver extending the validity of expired licenses will end when the Governor's emergency order ends.



#### A Message from the CEO

Although our in-person events were curtailed over the past year, the Executive Board hosted two virtual meetings to help maintain communication with member state boards and delegates. On September 19, 2020, 36 of 47 registrants attended the *Barbering Through COVID* meeting and all 27 registrants attended the February 22, 2021 mid-winter planning meeting. Thank you NABBA Members!

We also responded to those states requesting information or letters of support for their position on proposed regulatory changes. As we know, 2020 did not slow the deregulation efforts and results of certain NGOs, lobbyists, or self-serving "professionals". Case in point, Florida licensure hours were reduced from 1200 to 900, restricted hours to 600, and the legislature's most recent push is to allow barbers to perform services in locations other than a barbershop without any affiliation to a licensed shop! Since Florida does not require a hands-on practical exam, it now has the lowest licensing standards in the country . . . and we know similar deregulation legislation is taking place elsewhere.

#### NABBA Has A Seat At The Table!

Relevant to the topic of licensure hours, I received an email from the Council of State Governments advising us that they had "partnered with the U.S. Department of Defense to support the development of new occupational licensure interstate compacts... [that] will promote reciprocity and reduce the barriers to license portability, particularly for military spouses who face higher barriers to entry in state-licensed professions due to frequent relocation. And, they were "... seeking applications from professional associations, federations or associations of state licensing boards, a coalition of state licensing boards, or national credentialing bodies for professions that are licensed in at least 30 states". Permission to follow up was granted by the Executive Board.

#### Message from the CEO, continued

Since an interstate compact addressing military spouses could act as a springboard that impacts barbering (and cosmetology) on a broader scale to include other licensees, it is important that NABBA has been selected to be part of the Technical Assistance Group and subsequent discussions. Our seat at the table at the forefront of the initiative ensures that NABBA's collective voice on behalf of the barbering profession will be heard and reduces the risk of an irreversible fait accompli after the fact.

#### **Something to Think About**

Given the ongoing legislative threats and with a look ahead, I propose we begin to explore what we can do ... or may be called upon to do ... to fill the standards gaps created by legislative manipulations. I will discuss these concerns and the compact initiative in DC, but for the moment, please think about how we might ensure the continuation of professional standards and qualifications in new and different ways.

**DATE:** JUNE 25, 2021

#### I. Background

Board regulations set out the requirements for master esthetician licensure, including training requirements for exam eligibility and endorsement from another state. For those in-state, any person completing an approved esthetics training program or a master esthetics training program in a Virginia licensed esthetics school is eligible for the applicable examination.

For those coming from out-of-state, the language is not clear whether it applies to master esthetics training. The regulation states that a "person completing esthetics training that is substantially equivalent to the Virginia program but is outside of the Commonwealth of Virginia must submit to the board documentation of the successful completion of training to be eligible for examination. If less than the required hours of esthetics training was completed, an applicant must submit a certificate, diploma, or other documentation acceptable to the board verifying the completion of a substantially equivalent esthetics course and documentation of six months of work experience as an esthetician in order to be eligible for the esthetician examination."

#### II. Issue

The regulations concerning eligibility to sit for board-approved examination and training outside of the Commonwealth of Virginia does not clearly include master esthetics training as a method for qualifying for the board-approved examination. Going back to at least 2013, staff have interpreted the regulation to include both basic and master esthetics training, but the regulation itself uses the generic term esthetics.

#### III. Board Guidance

Staff would like guidance on whether out-of-state training for master esthetics can be accepted for exam eligibility. Staff recommend the following guidance, which would continue the current practice of accepting substantially equivalent master esthetics training:

<u>Substantial equivalence in relation out of state training to be eligible for the master esthetics examination</u>

The Board has determined that substantially equivalent esthetics course, in reference to 18 VAC 41-70-20(B)(2) means either:

"esthetics training program or a master esthetics training program"

This policy means that any applicant with esthetics training outside of the Commonwealth of Virginia will be required to submit to the board documentation of the successful completion of an esthetics training program or a master esthetics training program to be eligible for the applicable examination.



### Board for Barbers and Cosmetology July 12, 2021

**Guidance Document: Out-of-State Master Esthetics Training** 

An interpretation as to whether 18 VAC 41-70-20.B.2 requirement of substantially equivalent esthetics training for training outside the Commonwealth is meant to cover all esthetics training, including master esthetics training.

The Board has determined that a substantially equivalent esthetics course, in reference to 18 VAC 41-70-20.B.2 means either:

"esthetics training program or a master esthetics training program."

This policy means that any applicant with esthetics training outside of the Commonwealth of Virginia will be required to submit to the board documentation of the successful completion of an esthetics training program or a master esthetics training program to be eligible for the applicable examination.

**Assessment of a Student's Competency in Esthetics** – incorporates references to master esthetics that appear to have been omitted in the original document.

Barber & Cosmetology School Awarding Credits and/or Hours to Transfer Students – removes references to 18 VAC 41-40, which was repealed in 2017. Also contains several non-substantive grammatical changes and clarifications.

**Substantial Equivalence** – For endorsement, it incorporates the 80% hours rule for all board professions. This is the policy currently applied, as directed by the Board many years ago, but has never been formal guidance for esthetics or tattooing. For exam eligibility, also incorporates the 80% rule for esthetics and waxing, and inserts a clause stating the Board's pending experience waiver regulation for barbering, cosmetology, nails, and wax will automatically supersede this guidance.

**Cosmetology Examiners** – incorporates provisions to allow licensed cosmetologists to serve as wax technician examiners.

**License Required for Certain Procedures** – introduces new language in reference to scalp micropigmentation. While this appears to fall generally under permanent cosmetic tattooing, staff are asking for the Board's guidance on whether this falls under master or basic permanent cosmetic tattooing. This also makes two non-substantive, clarifying changes to other procedures.

**Barbering Scope of Practice** – staff are recommending repeal as the issue this document addressed has been resolved through legislation passed in 2018.

Endorsement Applicants Not Eligible for Temporary Permits – staff are recommending repeal at this time. The regulatory language around this issue is ambiguous when combined with the Board's decision to allow endorsement candidates to take the exam. These candidates often experience 4-6 week delay in working while they go through the examination process. In light of the General Assembly's directive to reduce regulatory burden, staff encourage the board to reverse this policy in order to benefit the endorsement candidates who are licensed in another

state, but required to take an exam in Virginia. This change would only impact endorsement candidates required to take an exam.

**Barber/Cosmetology Application Review Matrix** – incorporates recent changes to Virginia criminal law regarding possession of cannabis without the intent to distribute. These convictions would pass the matrix.

Barber Schools Previously Approved to Teach Training Equivalent to the Master Barber Curriculum – staff are recommending repeal at this time. This guidance was created to reduce the burden of existing schools while they navigated the statutory and regulatory changes associated with the new master barber license. Since the license has now existed for over three years, and there does not appear to be any remaining interest from the schools that could benefit, it does not appear this guidance is needed any longer.

**Definition of a Clock Hour** – makes a small grammatical correction.



### Board for Barbers and Cosmetology February 11, 2013

### Guidance Document: Assessment of a Student's Competence in Esthetics (Section 18 VAC 41-70-190.D)

On February 11, 2013, the Board issued the following guidance:

A licensed esthetics school with an approved esthetics program or an approved master esthetics program conducting an assessment of a student's competence in esthetics or master esthetics, may utilize-use documentation of hours instruction and practical performances provided to the student by a school, as provided for in Section 18 VAC 41-70-230, in addition to the successful completion of a board-approved competency examination administered by the school when giving credit towards the requirements specified in subsections B & and C of Section 18 VAC 41-70-190, and subsections A & and B of Section 18 VAC 41-70-200.

This guidance document is intended to assist its licensees and the public in understanding and applying the Board for Barbers and Cosmetology regulations. The law that governs the respective professions can be found in the Code of Virginia, 1950, as amended, in Title 54.1, Chapter 7. Regulations in electronic format can be found online at www.dpor.virginia.gov. ### Board for Barbers and Cosmetology September 17, 2020

#### **Guidance Document: Non-Traditional or Online Instruction**

In accordance with 18 VAC 41-20-200, 18 VAC 41-50-230, and 18 VAC 41-70-180 schools shall submit its curricula for Board approval and shall conduct classroom instruction in an area separate from the clinic area where practical instruction is conducted and services are provided.

The Board is providing the following guidance in the interpretation or implementation of the aforementioned regulations:

- Schools may offer non-traditional or 'online' instruction on all theory topics in their approved curriculum.
- School should utilize technologies and practices that are effective in verifying the identity of distance-learning students who participate in class or coursework (such as a secure login and pass code) while protecting student privacy.
- There is a measure of competency (examination) of the information the student is taught online which shall be completed in a traditional brick and mortar classroom.



### Board for Barbers and Cosmetology May 12, 2014

### Guidance Document: Barber and Cosmetology Schools – Awarding Credits and/or Hours to Transfer Students.

Interpretation of what may constitute a 'completed approved program' as noted in 18 VAC 41-20-20.B.1 and 18 VAC 41-40-20.B.1. Additionally, this method will be the sole manner in which a school may give credit for or allow transfer of hours in order to remain in compliance with 18 VAC 41-20-280.B.1-and 18 VAC 41-40-260.B.1:

A completed approved program may be composed of transferred hours under the following conditions:

- Both the new and former originating school must be licensed hold a valid license by the
  appropriate state licensing entity while the student is enrolled. The current curriculum must be
  approved by the state licensing entity schools' current curriculum must be approved by that
  entity.
- The <u>transfer</u> hours earned at the originating school must have been earned no more than two years prior to enrolling in the new school.
- Both the new and former <u>originating</u> school must be accredited <u>hold valid accreditation</u> by <u>a an accrediting agency recognized by the U.S. Department of Education recognized accrediting agency.
  </u>
- The new school may only credit transfer completed content hours, and must substantiate, based
  on the student's transcript, how the school accepted the hours were awarded towards each
  content area.

•	The applicant shall must be able to provide the Board with satisfactory evidence of the above.



### Board for Barbers and Cosmetology August 11, 2014

#### **Guidance Document: Substantial Equivalence**

#### Substantial equivalence in relation to licensure endorsement

The Board has determined that substantial equivalence in reference to 18 VAC 41-20-30, 18 VAC 41-50-30, and 18 VAC 41-70-30 means:

<u>"At least 80% of the required hours in Virginia and curriculum content covering Virginia's scope</u> of practice for that profession." <u>"80% of the required hours in Virginia"</u>

This policy means that any applicant with less than 80% of the required hours in Virginia is ineligible for license by endorsement.

Substantial equivalence in relation to examination eligibility in reference to 18 VAC 41-20-20, 18 VAC 41-50-20, and 18 VAC 41-70-20 means:

"At least 80% of the required hours in Virginia and curriculum content covering Virginia's scope of practice for that profession."

For cosmetology and master barber candidates with less than 80% of the hours, substantially equivalent training means the following-until the Board's regulatory change allowing experience to substitute for training hours takes effect.

Under 18 VAC 41-20-20.B.2.a., it states that,

"Any person completing a barber or cosmetology training program that is substantially equivalent to the Virginia program but is outside of the Commonwealth of Virginia must submit to the board documentation of the successful completion of 1,500 hours of barber or cosmetology training to be eligible for examination. If less than 1,500 hours of master barber or cosmetology training was completed, an applicant must submit a certificate, diploma or other documentation acceptable to the board verifying the completion of a substantially equivalent master barber or cosmetology course and documentation of six months of master barber or cosmetology work experience in order to be eligible for examination."

Substantially equivalent under this section means applicants would be eligible for examination if they have submitted documentation showing:

- 1,500 hours of training; or
- 1200-1499 hours of training (at least 80% of the required hours in Virginia) and six (6) months of full time work experience; or
- 1000-1199 hours of training and completion of the 'general' or 'intro' portions of the curriculum of an approved Virginia program (as provided below) and six (6) months of full time work experience; and

#### Continued on reverse

Any amount less than 1000 hours of training outside of Virginia will not count towards eligibility for examination.

The 'general' or 'intro' portions of the curriculum, as indicated in the Guidance Document for Non-Traditional Classroom Education, include the following courses:

- Orientation
- School Policies
- State laws and regulations
- Health and safety
- Personal hygiene

- Sanitation and Sterilization
- Ethics
- Salon/Shop/Parlor Management
- Analyzing skin or scalp conditions
- Anatomy
- Client Consultation
- Care of equipment

# Guidance Document: Barber and Cosmetology Endorsement – Endorsement Candidate from States Offering Only One Licensing Exam

Interpretation of whether the requirement in 18 VAC 41-20-30 that endorsement applicants must have completed a written and practical examination allows applicants from states with only one licensing exam to take the other exam in Virginia and still qualify for licensure by endorsement:

On November 17, 2014, the Board issued the following guidance:

An individual applying for licensure by endorsement under 18 VAC 41-20-30 whose state only utilizes one licensing exam (written or practical) may take the other exam (written or practical) in Virginia to qualify for endorsement.

# Guidance Document: Barber and Cosmetology Chief Examiners – Cosmetologists Can Serve as Nail Technician Examiners <u>or a Wax</u> Technician Chief Examiner

Interpretation of whether the requirement in 18 VAC 41-20-80.D that chief examiners hold a current Virginia license in their respective profession allows a cosmetologist to serve as a nail technician chief examiner or a wax technician chief examiner:

On November 17, 2014, the Board issued the following guidance: A cosmetologist can serve as an examiner for any license type that is included in the cosmetology profession, including nail technician or a wax technician under 18 VAC 41-20-80.D.

## Guidance Document: Barber, Cosmetology, Esthetics School Locations Interpretation of Location

Interpretation of what the requirement in 18 VAC 41-20-200.1 and 18 VAC 41-70-180.1 that schools hold a license for each and every location means:

On November 14, 2016, the Board issued the following guidance: For the purposes of schools with multiple suites or classrooms, a single location is one that is enclosed under one roof and all classrooms/suites are within 500 feet of the main office. Any suites or classrooms that are located in a different building or are further than 500 feet from the main office are considered a separate location, and require the school hold an additional license.



### **Guidance Document: License Required for Certain Procedures**

Interpretation of what license is required to perform certain procedures under Code of Virginia §54.1-700 et. seq.-, re: Eyelash Extensions, Microblading, Microneedling, Micropigmentation, Chemical Exfoliation

Applying eyelashes, as referenced in §\_54.1-700, refers to applying any natural or synthetic extension to an individual's natural eyelashes, also known as eye tabbing or eyelash extensions. This practice may be known as eye tabbing or eyelash extensions. These services require a cosmetologist cosmetology or esthetician esthetics-license.

Strip, band, or bundle eyelashes, which adhere to the skin, are services that are ancillary to makeup, and exempted under § 54.1-701.10.

Microblading, also called eyebrow embroidery, refers to the application of a semipermanent ink to the skin of the eyebrow. This practice, when performed with a needle or group of needles, requires a tattooing, or permanent cosmetic tattooing or master permanent cosmetic tattooing license.

Microblading performed with a scalpel is beyond the scope of licensure and should not be performed by a licensee of the Board.

Microneedling, also known as dermarolling, is the use of needles designed to pierce the skin for the purpose of collagen production or cellular renewal. This practice is beyond the scope of licensure and should not be performed by a licensee of the Board.

Micropigmentation, as listed in 18 VAC 41-50-10, used to be a term that meant permanent cosmetic tattooing, generally. However, that term now refers to a specific procedure, also called scalp micropigmentation. This procedure can be performed by an individual holding the tattooing, and [permanent cosmetic tattooer or master permanent cosmetic tattooer] license.

Chemical exfoliation is the removal of dead skin cells and/or the intercellular matrix through the use of chemicals. The Code of Virginia § 54.1-700 defines master esthetician as "a licensed esthetician who, in addition to the practice of esthetics, offers to the public for compensation, without the use of laser technology, lymphatic drainage, chemical exfoliation, or microdermabrasion...." Chemical exfoliation requires a master esthetician license. As such, estheticians may not use chemicals, including the chemicals listed in 18VAC 41-70-250.B, to remove dead skin cells or the intercellular matrix in the skin without holding a master esthetician license.



## Guidance Document: Esthetics – Cleaning Multiuse Items That Cannot Be Immersed

Interpretation of how to cleanse multiuse articles, tools, or products that cannot be immersed in light of 18 VAC 41-70-270.D.1, prohibiting multiuse items which cannot be cleansed.

While 18 VAC 41-70-270.A.2 requires multiuse items to be fully immersed during the disinfection process, certain multiuse articles, tools, or products cannot be fully immersed without damaging the item. Multiuse items that cannot be fully immersed without damaging the item should be cleaned according to manufacturer's recommendation.

Any multiuse items that cannot be disinfected by full immersion as specified in 18 VAC 41-70-270.A.2 or cleaned according to manufacturer's recommendation is prohibited from use per 18 VAC 41-70-270.D.1.



# Board for Barbers and Cosmetology August 21, 2017

### **Guidance Document: Barbering Scope of Practice**

It recently came to the Board's attention that several of the services required in the barbering school curriculum are beyond the barbering scope of practice as established by Code of Virginia § 54.1 700. The following clarifies the barbering scope of practice, and provides guidance to practitioners and schools regarding the affected regulations.

Code of Virginia §\_54.1-700 defines "Barbering" as "any one or any combination of the following acts, when done on the human body for compensation and not for the treatment of disease:

shaving, shaping and trimming the beard; cutting, singeing, shampooing or dyeing the hair or applying lotions thereto; applications, treatment or massages of the face, neck or scalp with oils, creams, lotions, cosmetics, antiseptics, powders, clays, or other preparations in connection with shaving, cutting or trimming the hair or a beard." This means the only services permitted under the Barber license are:

- Shaving, shaping and trimming the beard;
- Cutting, singeing, shampooing or dyeing the hair or applying lotions thereto;
- Applications, treatment or massages of the face, neck or scalp with oils, creams, lotions,
   cosmetics, antiseptics, powders, clays, or other preparations in connection with shaving, cutting
   or trimming the hair or a beard.

### REPEAL

For many years, the barber school curriculum has included Styling the Hair with a Hand Dryer, Thermal Waving, Permanent Waving with Chemicals, Wig Care, and Lightening or Toning the Hair. These services are not identified in the definition of barbering, and are outside the scope of the barber license.

#### For Practitioners and Barbershops

Because chemical texture services, thermal waving, styling, wig care, waxing, and lightening the hair are outside the scope of licensure, you should cease performing these functions immediately. These services fall under cosmetology, and require a cosmetology license for practitioners and a cosmetology salon license for businesses. Barbers and shops who wish to continue performing these services may wish to pursue those licenses. There are several ways for barbers to obtain a cosmetology license:

- Licensed barber with two years of experience can apply for a cosmetology license by examination. Eligible barbers may apply for the exam directly with the exam vendor.
- Barbers can complete a registered cosmetology apprenticeship and obtain a cosmetology
  license by examination. Cosmetology apprenticeships are 3,000 hours and are administered
  through the Department of Labor and Industry. Barbers can obtain credit towards
  apprenticeship hours based on their barber training and experience.
- Barbers can complete a cosmetology program in a licensed Virginia cosmetology school.
   Cosmetology programs are 1,500 hours. Barbers can apply some of the hours from their barber program towards the cosmetology course.

**Shops** that wish to obtain a cosmetology salon license can apply directly to the Board. Salon licenses require an application, fee, and fictitious /doing business as name documentation.

#### **For Schools**

There are several aspects of your curriculum which will need to change to come into alignment with the Code of Virginia. The Board is working to update the barber curriculum regulations to reflect the scope

of practice outlined in the law. In the meantime, licensed schools should cease teaching the following topics:

- Styling the Hair with a Hand Dryer,
- Thermal Waving,
- Permanent Waving with Chemicals, and
- Lightening or Toning the Hair

Schools should also eliminate the following performances:

- Cold Permanent Waving or Chemical Relaxing
- Bleaching and Frosting
- Wig Care, Styling, etc.,
- Finger Waving and Thermal Waving
- Waxing

Due to the reduction of coursework and performances, schools should reduce the program length to 1,100 hours by March 1, 2018. Schools will need to submit a new syllabus, course outline, and breakdown of hours and performances to the Board prior to implementing the new hours. These documents can be submitted by email to barbercosmo@dpor.virginia.gov, or mailed to the Board at the address on the letterhead. Students who began the program under 1500 hours can complete the 1500 hour curriculum.

The Board is working with our exam developer to replace the current exam with the appropriate exam for the scope of practice. The new barber exam will not include any chemical services, including waving, relaxing, or coloring. The current exam will be replaced by this new barber exam by the end of November, 2017. There will be a new Candidate Information Bulletin for the exam posted on www.pcshq.com in the coming weeks.

## **Guidance Document: Endorsement Applicants Not Eligible for Temporary Permits**

Interpretation of whether 18 VAC 41-20-90 – Barber, cosmetology, nail technician, and wax technician temporary permits, or 18 VAC 41-70-70 – Esthetician Temporary Permits, allow endorsement applicants to receive temporary permits.

18 VAC 41-20-90 and 18 VAC 41-70-70 allow for temporary licenses to be issued to applicants for initial licensure that the Board finds eligible to sit for the exam. Because endorsement candidates already have a license and they are not applicants by examination, they are not eligible for temporary permits.

### Application Review Matrix Criminal History

#### The following convictions will not be reviewed by the Board\*:

- 1. Felony convictions more than 20 years old with no subsequent reportable convictions of a similar nature, unless the conviction resulted in incarceration where the release date is less than three years from the application date.
- 2. Felony convictions more than five years old with no subsequent reportable convictions of a similar nature, unless the conviction resulted in incarceration where the release date is less than three years from the application date. This does not include convictions involving murder, sexual assault, rape, robbery, indecent liberties, fraud, embezzlement.
- 3. Felony convictions for possession of controlled substance more than two years old, where the applicant has completed a deterrence program if required by the court.
- 4. Felony convictions of Title 46 of the Code of Virginia (Traffic Code) more than two years old.
- 5. Any conviction for possession of up to one ounce of cannabis, without intent to distribute.
- 6. Misdemeanor convictions where the applicant has no record of felony convictions.
- <u>7.</u> Misdemeanor convictions more than one year from the date of application.
- <u>8.</u> Misdemeanor convictions for assault, disorderly conduct, drunk in public, petit larceny, failure to appear, and/or trespassing.
- <u>9.</u> Misdemeanor convictions for possession or distribution of a controlled substance with no other convictions.
- <u>10.</u> DUI convictions where the applicant has completed VASAP or another similar program accepted by the court or DMV after the latest conviction if required by the court. This does not include felony convictions.
- 11. Juvenile convictions.

<sup>\*</sup>The matrix shall not apply to applicants who are currently incarcerated, except those incarcerated for juvenile convictions.

## Guidance Document: Barber Schools Previously Approved to Teach Training Equivalent to the Master Barber Curriculum

Interpretation of barber schools that were previously approved to teach the 1,500 hour training that is equivalent to the master barber regulations can reinstate the 1,500 hour training program when the master barber regulations become effective.

Recognizing that the master barber training program is substantially identical to the 1,500 hour barber training program previously taught by licensed barber schools, the Board for Barbers and Cosmetology issues the following guidance to schools with these previously approved programs:

Barber schools that were previously approved by the Board to teach the 1,500 hour barber program may have their 1,500 hour program reinstated as a dual barber/master barber program upon resubmission and Board approval of their course syllabus, detailed course outline, and breakdown of hours and performances.

## **Guidance Document: Approved Health Education Certifying Agencies**

The following health education (as referred to in 18 VAC 41-50, including limited term tattooers, and 18 VAC 41-60) is deemed acceptable to the Board. Documentation verifying course completion shall bear the name of the individual as it appears on the application or license as well as the name of the Board approved certifying agency.

#### **Content delivery requirements:**

Adult CPR – no more than ½ the content delivered online; ½ in person/classroom First Aid – no more than ½ the content delivered online; ½ in person/classroom Bloodborne Pathogens – may be in person or online

Applicants who completed a Board approved 1,500 hour barbering program, 3,000 hour registered barber apprenticeship, or a Department of Education barbering program and who passed the barbering examinations prior to December 11, 2017 meet the training and examination requirements for the master barber license as established 18 VAC 41-20-20.

Applicants who completed a Board approved 1,500 hour barbering program, 3,000 hour registered barber apprenticeship, or a Department of Education barbering program, but who were unable to take the barbering exam prior to December 11, 2017 meet the training requirements for the master barber license as established 18 VAC 41-20-20, but will need to pass the master barber examinations in order to qualify for the license.



# Board for Barbers and Cosmetology July 25, 2019

#### **Guidance Document: Master Barber Endorsement**

18 VAC 41-20-30 - Interpretation of when a master barber endorsement candidate is considered "licensed to practice as a master barber" in another state.

On May 13, 2019, the Board issued the following guidance:

Individuals whose out-of-state barber or master barber license allows them to perform the services that fall under the master barber license in Virginia are considered licensed to practice as a master barber for the purpose of endorsement.

Interpretation of what constitutes an hour of school instruction under 18 VAC 41-20, 18 VAC 41-50, and 18 VAC 41-70.

Clock hour, as used in reference to the hours of instruction requirements established in the regulations, shall have the samemeaning as "Clock hour" under State Council of Higher Education for Virginia Regulation 8 VAC 40-31-10. ""\_Clock (or contact) hour" means a minimum of 50 minutes of supervised or directed instruction and appropriate breaks."


Included in your agenda packet are communications regarding two conferences this fall.
