Within 6 months from the date of entry of the Order, Dr. Lynch shall successfully complete a 4 hour continuing education course in the subject of billing and coding; a 4 hour continuing education course in the subject of recordkeeping and risk management; a 7 hour continuing education course in the subject of treatment planning and placement of implants; and a 4 hour continuing education course in the subject of managing complications with dental implants.

Dr. Bigelow moved to adopt the decision of the Committee. The motion was seconded and passed.
