

COMMISSION MEETING HELD FEBRUARY 21, 2012

Minutes of the meeting of the Commission, held at the Department of Forestry, 900 Natural Resources Drive, Suite 800, Charlottesville, Virginia.

Fred Calvert called the meeting to order at 10:30 a.m.

Fred Calvert asked if there were additions or corrections to the previously distributed December minutes. The minutes were accepted.

The Administrator presented and discussed the 2012 base allotments. Having considered all factors relative to the establishment of the 2012 base allotments, upon a motion by Gerald Heatwole and seconded by Kenneth Smith the Commission approved all established bases for 2012 would be 75,744,312 pounds (in accordance with 2 VAC 15-20-40. A1-5), in that the 2012 bases do not exceed 1.08% of the average monthly pounds of Class I sales, with the exception of those producers who lost base or recovered base during the base-adjusting period of September, October and November 2011. The bases of existing producers will be adjusted on March 1, 2012 to include base loss and base recovered. The total base recovered from the 2010 base adjusting period was 186,978 and the total base loss due to failure to produce sufficient production during 2011 base-adjusting period was 154,101 pounds. The base recovered and base loss will bring the total established 2012 base to 104.558673% of the preceding year's average 9 month Class I sales, in the amount of 71,025,088 pounds. The amount of base for the months of June, July and August shall be equal to 95% of the established base for the remaining months of the year. The 2012 base allotments, in total by cooperatives, as listed below, are therefore established for the existing baseholding producers, effective March 1, 2012:

The Administrator presented a letter from Mr. Doug Greenway, a representative of Dairy Farmers of America (DFA), requesting a base hardship for Jesse Rohrer (License no. 4574). The interpretation of the letter was in an attempt to preserve 733 pounds of base that Mr. Rohrer had in escrow; DFA had consigned and transferred the base. After the transfer was completed by the Commission, DFA realized that the action would not result in preserving the base. Therefore DFA was asking to restore the base in escrow. After consideration, particularly for the benefit of Mr. Rohrer a motion was made by Commission Member, Gerald Heatwole and duly seconded by Commission Member, Jessica Jones to deny the request. The motion carried.
