Attachment 1

Agricultural Land: Defined as "land being used in a BONA FIDE program of agricultural management and engaged in the production of agricultural, horticultural or forest products for market. The real estate must consist of a minimum of five contiguous acres and have verifiable gross receipts in excess of \$1,000 per year from the production or sale of agricultural, horticultural or forest products produced, or revenue generated from livestock activities on the applicant's agricultural land for each of the past five years.

Agricultural Products: Crops, livestock and livestock products or activities that create the need for agriculture best management practices to, including but not limited to: field crops, forage, fruits, vegetables, horticultural specialties, cattle, sheep, hogs, goats, horses, poultry, furbearing animals, milk, eggs, and furs., and equine activities that create the need for agriculture best management practices to reduce nonpoint source pollutants.

Agricultural Production: The production for commercial purposes of crops, livestock and livestock products, and includes the processing or retail sales by the producer of crops, livestock or livestock products which are produced on the parcel or in the district. For livestock operations, the agricultural product includes revenue generated from activities which are conducted on the parcel or in the district and that create the need for agriculture best management practices to reduce nonpoint source pollutants.

Attachment 2

Agricultural Land: Defined as "land being used in a BONA FIDE program of agricultural management and engaged in the production of agricultural, horticultural or forest products for market. The real estate must consist of a minimum of five contiguous acres and have verifiable gross receipts in excess of \$1,000 per year from the production or sale of agricultural, horticultural or forest products produced on the applicant's agricultural land for each of the past five years.

Agricultural Products: Crops, livestock and livestock products that create the need for agriculture best management practices to, including but not limited to: field crops, forage, fruits, vegetables, horticultural specialties, cattle, sheep, hogs, goats, horses, poultry, furbearing animals, milk, eggs and furs.

Agricultural Production: The production for commercial purposes of crops, livestock and livestock products, and includes the processing or retail sales by the producer of crops, livestock or livestock products which are produced on the parcel or in the district. For purposes of the VACS program, commercial equine operations such as breeding, boarding and training facilities are eligible for funding if they meet the necessary acreage and income requirements for each of the past five years.
