Both, Mr. Ingrao and Ms. Donahue spoke in opposition of the \$50.00 fee on behalf of the Virginia Apartment Management Association and requested the Board to lower the \$50.00 fee. There were approximately sixty-five (65) people present to show support for the lowering of the Fair Housing Certification fee. Ms. Ware, Director, addressed their concerns.

Public Comment Period

A motion was made by Ms. Clare and seconded by Ms. Harmon to adopt additional Emergency Regulations with the fee for certification in the amount of \$25.00. The motion passed unanimously.
