Meeting Called to Order

The meeting was called to order at 10:40 am.

Public Comments

Acceptance of Meeting Minutes

Kenneth Mitchell made a motion to accept the draft minutes from the April 13, 2011 meeting as presented. Andres Alvarez seconded the motion, and it passed unanimously.

Discussions – Compliance Matters

Barbara Drudge provided information on an operator that failed to provide information on criminal convictions on its renewal application related to the owner and responsible individual, and which was a companion matter that resulted in a letter of reprimand, as to the driver. Chairman Brown asked for additional information as to the convictions for consideration at the next Committee meeting.

The Committee reviewed the matter of Carroll Payne and Payne's Body Shop, presented by Barbara Drudge and John Beall, who chaired the Informal Fact Finding Conference ("IFFC") on behalf of the Board. The IFFC began on May 2, 2011 and was continued at the request of their counsel of record,

Richard Gardiner. Mr. Gardiner presented a proposal to the Committee to reduce the Board imposed fines from \$500 to \$250, and to allow Mr. Payne and Payne's Body Shop to keep their respective Board issued license and authorizations.

Mr. Alvarez made a motion to accept Mr. Gardiner's appeal, and Mr. Mitchell seconded the motion. All were in favor.
