Welcome & Introductions

Regulatory Update

Richard Martin, Manager of the Office of Legislative and Regulatory Affairs provided members with a regulatory update. This report is attached to the Council meeting file.

Discussion:

Ms. Hulcher confirmed with Mr. Martin that the Council voted to skip the periodic review on items 2 and 7 mentioned in the handout. It was confirmed the Council voted and approval was given on May 14, 2009 to skip the periodic review.

Committee Reports

Leslie Knachel, Licensing Manager provided an update on the various RAP groups. There will be a RAP group meeting today following this meeting and another scheduled for September 22.

Ms. Knachel confirmed that the RAP groups are writing the standards and using a team approach with DSS to provide the interpretation. Each workgroup is reviewing their section. If the Council disagrees as a whole as to the language a particular RAP group used, then the RAP group responsible will redraft and bring it back to full Council for review and adoption.

Ms. Dowdy confirmed with Mr. Martin that the Council is allowed to have input on updating the technical interpretation document. It was also confirmed that once the Council adopts the regulation it belongs to Commissioner and department staff to interpret from a legal standpoint.

First drafts on RAP group input are due at the end of December per Ms. Knachel.

There has not been very much public participation at the various RAP meetings and Council wants to look at ways to engage others.

Public Comment

Sharon Jones, Government Policy Chair for the Alliance for Choices in Child Care spoke to the Council on proposed regulation 22 VAC 15-31.

Gail Johnson, former Chair of the Council shared her thoughts and appreciation having served on the Council for the past eight years.
