C.5. to read, "Staff members without medication administration training may apply diaper ointment, unless it is prescription diaper ointment, in which case the storing and application of diaper ointment must meet medication related requirements".

B. 8. that reads, "Individual disposable barriers may be used between each diaper change. If a barrier becomes soiled the surface shall be cleaned and sanitized before another child is diapered".

ON MOTION DULY MADE (Mr. Walter) and seconded (Dr. Simpkins) moved to amend 22 VAC 15-30-10. Definitions. 13. to read, "Group of children" means the children assigned to a staff member or team of staff members". The following language was omitted, "occupying an individual classroom or well-defined space within a larger room.

ON MOTION DULY MADE (Ms. Hackney) and seconded (Mr. Tobin) moved to amend 22 VAC 15-30-461. Daily activities for infants. 3. to read, "3. Outdoor time if weather and air quality allow based upon the air quality index color chart as provided by the Department of Environmental Quality at http://www.deq.state.va.us/. The remainder of the paragraph beginning with, "children may go outside to play when the color code is either green or yellow. Children may not go outside to play when the color code is orange, red, or purple" is deleted.

ON MOTION DULY MADE (Ms. Snyder) and seconded (Ms. Steele) moved to amend 22 VAC 15-30-630. Special feeding needs. H, last sentence to read, "Formula or breast milk shall not remain unrefrigerated for more than two hours.

ON MOTION DULY MADE (Ms. Snyder) and seconded (Mr. Harvey) moved to amend 22 VAC 15-30-630. Special feeding needs. H. to read "Prepared baby food not consumed during that feeding by an infant may be used by that same infant later in the same day, provided that the food is not served out of the baby jar and

is dated and stored in the refrigerator; otherwise, it shall be discarded or returned to the parent at the end of the day. Formula or breast milk shall not remain unrefrigerated for more than two hours and may not be reheated.

ON MOTION DULY MADE (Ms. Hulcher) and seconded (Ms. Thornton) moved to amend 22 VAC 15-30-640. Transportation and field trips. F. to read, "The staff-to children ratios of 22 VAC 15-30-440 E, G and H shall be followed on all field trips. The staff-to-children ratios need not be followed during transportation of school age children to and from the center. One staff member or adult is necessary in addition to the driver when 16 or more pre-school or younger children are being transported in the vehicle".

ON MOTION DULY MADE (Mr. Walton) and seconded (Dr. Simpkins) moved to delete "and group size requirements." in the descriptive statement of 22 VAC 15-30-440. Staff-to-children ratio requirements.

ON MOTION DULY MADE (Mr. Harvey) and seconded (Ms. Hackney) moved to approve the final regulatory package for 22 VAC 15-30 et seq., Minimum Standards for Licensed Child Day Centers to be published in The Virginia Register subject to approval under the provisions of Executive Order Number 21 (2002) and the issuance of a letter of assurance by the Office of the Attorney General. Under provisions of the Administrative process Act, this regulatory action may be effective 30 days after publication; however it shall be effective no earlier than January 1, 2005.

It was further moved that Assistant Attorney General Allen Wilson and Regulatory Coordinator Richard Martin be authorized to make simple formatting, grammatical, and technical edits to the final regulatory package in order to conform the regulation to the Virginia Administrative Act and other state laws.
