- 2. Approval of past minutes. (Senator Barbara Favola)

### 3. VOCA Funding Strategy/Updates

John Mahoney, VOCA Administrator at DCJS, presented an overview of the VOCA funding, current allocation of VOCA funds, the release of the Request for Proposals (RFP) for continuation and expanding VOCA projects for FY17-19, and plans for funding for new VOCA projects.

4. Virginia Sexual and Domestic Violence Professional Standards Committee (Kay Bullock)
An overview of the first meeting of the Professional Standards Committee (PSC) was provided.
This included a summary of the vision, purpose, and values, identified by the Professional Standards Committee. The next PSC meeting will be scheduled in June, 2016.

### 5. Advisory Committee Bylaws (Fran Ecker)

A draft of the Advisory Committee Bylaws was reviewed. Committee members were asked to review the bylaws document and provide any feedback or revisions to Kay Bullock by May 30, 2016. A request was made for DCJS to send a copy of the report on the listening sessions to members of the Committee.

6. **Agency Roundtable Discussion.** Members of the Advisory Committee that represent state agencies or statewide non-profit organizations provided agency updates related to domestic and sexual violence.

#### 7. Legislative Update. (Senator Favola)

An update on the legislative changes that were made in the 2016 session that impact victims of domestic and sexual violence was presented.
