Milk Commission Meeting Held June 20, 2019

Minutes of the meeting of the Milk Commission, held at the Department of Forestry located at 3806 Lawyer Road, McGaheysville, VA 22840.

Mr. Heatwole called the meeting to order at 1:30 p.m.

Mr. Heatwole asked for a motion to accept the minutes from the previous meeting. Mr. Kerr so moved and Ms. Carlson seconded the motion. The minutes were accepted as presented at the meeting.

Mr. Wilkes gave a review of Class I and Class II prices, production, and sales. Forecasts continue to show average prices up about \$1.00 over 2018, but recently the outlook has not been as optimistic as it was to start the year. Mr. Jon Bebermeyer, Dairy Farmers of America (DFA), noted that world milk production has dipped, which is favorable and a dollar rise for the remainder of the year is a possibility. Mr. Heatwole added that the Class I Price compared to 2018 was up \$1.82, which is helpful, but still needs to come up. He also believed that the Dairy Margin Coverage Program would be helpful to farmers in the future. Mr. Wilkes stated that the Milk Commission increased the Adjacent Market Price approximately \$0.20 beginning in June based on trends in surrounding areas, but the Commission operates on a delay, so many of those surrounding areas saw increases in April. According to Mr. John the Pennsylvania Milk Marketing Board (PMMB) increased its premium \$0.25 in April. Mr. Linney asked if the Commission was directly influenced by the PMMB, and Mr. Wilkes responded that any change the PMMB made would influence the Commission because milk from the state is sold in Virginia, but it would be indirect in nature. Mr. John and Mr. Bebermeyer agreed that increased prices may lead to more farmers exiting the industry as cull prices would also improve.

Year-to-date fluid sales appeared to be down through May 2019, but several reporting issues may be the cause of much of the drop. Premium products, whole milk, and flavored milk showed varying improvements in sales, but did not compensate for losses in other areas. Mr. Wilkes also reviewed a pricing comparison between regulated markets in Virginia and unregulated markets. Despite pricing controls and higher raw product costs, the consumer retail price in Virginia is highly competitive when compared to areas that do not enforce minimum prices.

Mr. Heatwole made closing comments regarding his time served as chairman of the Milk Commission before opening the floor to nominations. Mr. Mayer nominated Mr. Kerr, and the board voted unanimously in favor.

The meeting opened for public comment. There was no further public comment.

The next Commission meeting is tentatively scheduled for 1:30 p.m. on Wednesday, September 18, 2019 in Charlottesville.




