Ms. Burton also spoke to the Board about the Board's Guidance Document related to the transfer of student hours, and the requirements for obtaining a Tattoo instructor certification. Mr. Matt England, Master Esthetics Instructor at LAT, Inc./Institute of Advanced Medical Esthetics, regarding the transition to the National-Interstate Council of State Boards of Cosmetology (NIC) exams under Professional Credential Services, noting that the NIC exams allow for the use of a mannequin head or live model, depending on the state, and suggesting that the Board consider the use of mannequin heads only. Mr. England also spoke with the Board on the topic of the waxing portion of the practical exam and the use of hard wax vs. simulated soft wax. Additionally, Mr. England asked the Board to consider omitting make-up application from the esthetician practical exam. The Board took Mr. England's comments under advisement.

Ms. Christine Werne, of the Chrysm Institute of Esthetics, reiterated Mr. England's comments and concerns, and further addressed the Board on the topic of location, referring specifically to the Chrysm Institute's physical location and layout. Mr. Melis indicated that this issue is an agenda item for discussion by the Board later in the meeting, and the Board took Ms. Werne's comments under advisement.

Mr. McKinley Stockton, owner and instructor at Barber College in Woodbridge, VA, spoke to the Board regarding transfer of student hours from another school, and asked that the Board consider eliminating the requirement that both schools be accredited by an accrediting agency recognized by the U.S.
