Ms. Hucks reported that the Committee found that Dr. Farhoumand practiced outside the scope of her education, training, and experience on two occasions, including August 26, 2013 when she authorized 120 dosage units with 6 refills, when she telephonically ordered prescriptions for Individual A for lamotrigine, a Schedule VI controlled substance used by Individual A for approximately 20 years to treat his depression.

The sanction reported by Ms. Hucks was that Dr. Farhoumand shall pay a \$1,000.00 monetary penalty.

Dr. Wyman moved to adopt the decision of the Committee. The motion was seconded and passed.

Ms. Hucks reported that the Committee found that while providing treatment to Patient A, Dr. Abdeen failed to perform an endodontic evaluation or provide a referral to a specialist, despite the fact that Patient A complained of continual pain throughout the crown delivery procedure for teeth #18 and 19.

The Committee also found that Dr. Abdeen permanently cemented the crowns on teeth #18 and 19, although Patient A informed him that she had pain associated with the teeth; and according to Dr. Abdeen's own records, Patient A was very uncooperative, angry, and crying during the process.

The Committee further found the x-ray taken of Patient A's temporary crowns on teeth #18 and 19 showed excessive remaining temporary cement.

The sanctions reported by Ms. Hucks were that Dr. Abdeen shall pay a \$3,000.00 monetary penalty; and that within 6 months from the date of entry of the Order he shall successfully complete a 7 hour continuing education course in endodontics and 4 hours of continuing education in risk management.


Dr. Wyman moved to adopt the decision of the Committee. The motion was seconded and passed.
