Captain Cofer motioned to suspend the license of Captain John Brockington Beasley, Jr., effective immediately, due to the risk of continued practice constituting a substantial danger to the public's health and safety in accordance with subsection B of §54.1-902 of the Code of Virginia. At the same time, an informal fact-finding conference shall be held within a reasonable timeframe in accordance with § 2.2-4019 of the Code of Virginia. Ms. Piersall seconded the motion which was unanimously approved by Messrs., Mme. and Captains: Callis, Chisman, Cofer, Host, McDermott, Piersall, and Stone by stating aye. None opposed.
