Regarding File Number 2006-03471, A. Scott McDowell, the Board reviewed the record of the Informal Fact-Finding Conference, which consisted of the application file, transcripts and exhibits, the Summary of the Informal Fact-Finding Conference, and Mr. McDowell's e-mail. Mr. Atkinson moved to accept the recommendation of the presiding Board member and deny Mr. McDowell's application for certification as a wetland delineator as he has not submitted adequate proof that he is able to properly identify vegetation indicators for the delineation of wetlands. Mr. Galbraith seconded the motion which was approved unanimously by members: Atkinson, Daniels, Davis, and Galbraith.

The Board members reviewed a legislative proposal for consideration for Discussion of Legislation the 2007 session to change the waiver period for certification in §54.1-2206.2 of the Code of Virginia from two years to six years. Mr. Daniels made a motion that the Board submit the proposed legislation for consideration for the 2007 legislative session. Mr. Atkinson seconded the motion which was unanimously approved by members: Atkinson, Daniels, Davis, and Galbraith.

The Board members were provided with the Board financial statements for March 2006 for informational purposes.
