Enforcement Committee
Meeting Minutes
December 2, 2009

The Virginia Board of Accountancy's Enforcement Committee met on Wednesday, December 2, 2009, at 9960 Mayland Drive, Perimeter Center, 2nd Floor Commonwealth Conference Center, and Richmond, Virginia 23233
